WHEREAS, WAVETECH ENTERPRISES, LLC (Respondent Wavetech), is an active domestic limited liability company, formed on October 25, 1999, located at 9120 Double Diamond Pkwy., Suite 4400, Reno, NV 89521. Respondent Wavetech's Nevada Secretary of State Business License Number is NV19991082444. Respondent Wavetech is not now, nor has it ever been, registered with the Nevada Securities Division (Division).

WHEREAS, DEL MAR INVESTMENTS (Respondent Del Mar), is an active domestic corporation, formed on October 25, 1999, located at 9120 Double Diamond Pkwy., Suite 4400, Reno, NV 89521. Respondent Del Mar's Nevada Secretary of State Business License Number is NV19991405373. Respondent Del Mar is not now, nor has it ever been, registered with the Division.

WHEREAS, JOHN MOIR (Respondent Moir) is the President, Secretary, Treasurer, and Director of Wavetech and Del Mar, and is also located at 9120 Double Diamond Pkwy.

WHEREAS, the Division filed an action against Respondent on July 12, 2021;

WHEREAS, pursuant to NRS § 90.330, it is unlawful for any person to transact business in this State as an investment adviser or as a representative of an investment adviser unless that person is licensed or exempt from licensing under the Act;

WHEREAS, Respondents violated NRS § 90.330 by acting in the capacity of an investment adviser when they received compensation on at least nine separate occasions for their services in making securities transactions in client accounts while not being registered with the Division;

WHEREAS, Respondent Moir acted in the capacity of a representative of an investment adviser when he signed agreements and agreed to manage client accounts using client account names and passwords to transact business in client accounts;

WHEREAS, Respondent Moir violated NRS § 90.330 by acting in the capacity of a representative of an investment adviser without being licensed under the Act;

WHEREAS, Respondents have advised the Division of their desire to resolve the above failure to comply with the requirements of Nevada's Uniform Securities Act, on the terms specified within this ACO;

WHEREAS, Respondents elect to permanently and expressly waive any right to a hearing and appeal under the Act and/or to seek judicial review under the Nevada Administrative Procedure Act, NRS Chapter 233B, with respect to this Order.

NOW THEREFORE, the Administrator, pursuant to the Act, hereby enters the following:

ORDER

Finding the following appropriate and in the public's interest, and on the basis of the foregoing, and Respondents' consent to the entry of this Order,

IT IS HEREBY ORDERED:

- 1. Respondents will cease from violating the Act and will comply with said Act.
- 2. Respondents will pay the Nevada Secretary of State a civil penalty in the cumulative amount of \$10,000.00 due upon the schedule set forth below and upon entry of the Respondents' consent to entry of this Administrative Order.
 - a. Due upon signing, \$500;
 - b. Due on October 1, 2022, \$3,000;
 - c. Due on September 1, 2023, \$6,500.

All amounts submitted under this section shall be remitted to:

- 3. Respondents are permanently barred from acting as an investment advisor, an investment advisor representative, a broker-dealer, or a broker-dealer salesperson in the state of Nevada.
- 4. In consideration, the Division will take no further enforcement action based upon the circumstances covered by this investigation and Order and close its administrative investigation of the Respondents in connection with the aforementioned activities.
- 5. Nothing in this Order shall be construed as a waiver of the Division's right to investigate and pursue any violations by Respondents in connection with other activity not set forth herein or within the Division's Summary Order to Cease and Desist issued on July 12, 2021.
- 6. Nothing in this Order is intended to limit or create for third parties any private remedies against Respondents.

7. This Order shall be effective as of the date on which it is signed by the Administrator as set forth below. The Hearing scheduled for November 4, 2021 is vacated and the Agency Action is dismissed.
