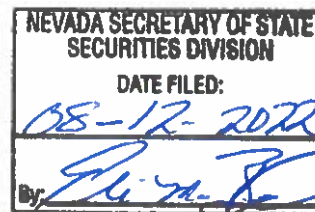

**WHEREAS**, the Securities Division of the Office of the Nevada Secretary of State (Division) filed a Summary Order against Respondent on January 25, 2022. Pursuant to NRS 90.800, the Division served Respondent via certified mail at 5852 Arrowleaf Street, North Las Vegas, NV 89031. (Exhibit 1).
