**ADMINISTRATIVE CONSENT ORDER**

**File No. CIC17-159**

**WHEREAS, ELYSIEN PRIVATE WEALTH, CRD No. 151511, is a Nevada-based investment adviser firm located at 871 Coronado Center Drive, Suite 200;**

**WHEREAS ANTHONY DEPASQUALE, CRD No. 4545724, is a Nevada-based investment adviser licensed with the State of Nevada since December 16, 2009, located at 871 Coronado Center Drive, Suite 200;**

**WHEREAS, on October 26, 2021 the Nevada Securities Division (Division), pursuant to the Administrator's authority under NRS § 90.410, filed a Complaint for Summary Order and Final Order to Cease and Desist against Respondents;**

**WHEREAS, that action alleged Respondents failed maintain and provide certain books and records in a legible form, a violation of NRS 90.410, failed to maintain accurate general ledgers over a period of five years, a violation of NAC 90.3864(3) and 17 C.F.R. 275.204-2(a)(1-3), failed to regularly file and maintain an accurate Form ADV, a violation of NAC 90.380 (2, 3) and NRS 90.390(7), and violated their fiduciary duty owed towards clients, a violation of NRS 90.575;**

**WHEREAS**, Respondents admit to all of the allegations contained in the Division's Complaint and have advised the Division of their desire to resolve the above failure to comply with the requirements of Nevada's Uniform Securities Act (Act), on the terms specified with this Administrative Consent Order;

**WHEREAS**, Respondents elect to permanently and expressly waive any right to a hearing and appeal under the Act and/or to seek judicial review under the Nevada Administrative Procedure Act, NRS Chapter 233B, with respect to this Order.

**NOW THEREFORE**, the Administrator, pursuant to the Act, hereby enters the following:

## ORDER

Finding the following appropriate and in the public's interest, and on the basis of the foregoing, and Respondents' consent to the entry of this Order,

**IT IS HEREBY ORDERED:**

1. Respondent Elysien Private Wealth, CRD #151511, shall have its securities license revoked upon the execution of this Order, and is permanently barred from the securities industry in Nevada.
2. Respondent Anthony DePasquale, CRD # 454724, shall have his securities license revoked upon the execution of this Order, and is permanently barred from the securities industry in Nevada.
3. In consideration, the Division will take no further administrative enforcement action based upon the circumstances covered by the allegations contained in the Division's Complaint and Order dated October 26, 2021, and dismiss the same in connection with the activities enumerated therein.
4. Nothing in this Order shall be construed as a waiver of the Division's right to investigate and pursue any violations by Respondents in connection with other activity not set forth within the division's October 26, 2021 Complaint, nor shall this agreement be construed as a waiver of the Division's right to investigate and pursue any criminal violation by Respondents.


1 5. Nothing in this Order is intended to limit or create for third parties any private remedies  
2 against Respondents.

3 6. This Order shall be effective as of the date on which it is signed by the Administrator as  
4 set forth below.


