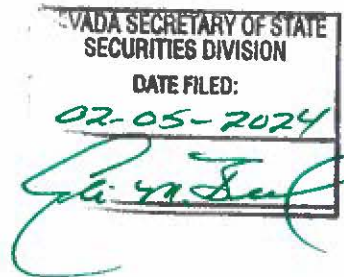

- 12 6. Nothing in this Order shall be construed as a waiver of the Division's right to investigate  
13 and pursue any violations by Respondents in connection with other activity not set forth  
14 herein.
- 15 7. Nothing in this Order is intended to limit or create for third parties any private remedies  
16 against Respondents.
- 17 8. This Order shall be effective as of the date on which it is signed by the Administrator as set  
18 forth below.
