

- Addressed statutory requirements

- NT7's and NRS 81 entities can now request copies of their Business License online
- Certified copy requests internal and external orders certification page
- Certified copies can now be ordered "as a packet" internally
- When changing an entity name a Business License will be generated with the new name and included in the filed stamped copies.
- Out of State Charitable Solicitation Registration Statement
- Customers will be able to renew a defaulted entity on the cusp of being revoked without an error, the system shall update the entity status to default and will allow the customer to file for the next renewal period.
- Entities that are in a Permanently Revoked status will now reflect correctly and will not hinder customers from being able to file the appropriate filing.
- SilverFlume Business Search has been updated to show an entity's entire filing history and is no longer limited to the most recent 10 actions.
- Customers will have the ability to enter in a termination date for Limited Partnership's (88) with no issues
- Corrected displayed data for NT7 due dates
