- Address Trademark Filings

- Addressed statutory requirements

Where you will see the new Functionality in our System

- Users will now have a button titled Right of Publicity located in the Supporting Documentation section that they can click to print the application, sign, and upload.
- Upon filing approval for the Right of Publicity users will receive Receipt, Filing Acknowledgement, and Application for Registration.
- Users can now select Claimant name to be either individual or entity.
- Online Merger filings will reflect all acquired entities on official filed document.
- Foreign Corporation Sole Annual List
- Online Professional LLC and Professional Corporation requiring the Professional License upload
- Limited Partnerships NRS 87A and 88 can update the records office
- Initial, Annual and Amended list management and signatures are now per NRS.
- Users will receive an alert when creating a new entity name that contains the word College or University. The user will be advised that to receive for the name, they will need approval from the Commission of Post Secondary
