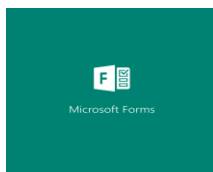

What's New/Corrected

Modernized Navigation for filing flow selections

Where you will see the new Functionality in our System

- Modernized screen navigation when viewing In Progress Filings and/or selecting filings to process.
 - Navigating filing selections through the scroll bar along the top of the screen has been removed, users will now be presented with a collapsible menu tool along the left-hand side of the screen.
 - In Progress Filings can be viewed by selecting "My Dashboard" in the menu. Users can select the filing Category such as UCC, or Business, to view any in progress filings they have.
 - Filings such as Formations or Amendments can be expanded through the associated menu line item, to allow the user to view all options available for that filing type.
