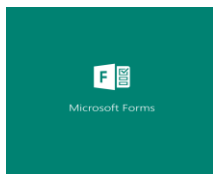

**Certificates and Copies Requests**

1. Users will be required to select a certificate when they request an Apostille copy. There is a pop-up alert to External Users to help enforce this requirement and the system will not allow them to move forward without the certificate selection.
2. When Users submit copies request for a Certificate of Good standing with Amendments, the current Entity Name will display.

Enhancements

1. The Assigned Commercial Registered Agent will receive an emailed notification advising that they are showing as representing an entity when the following filing flows are completed (sample email imaged below):
  - a. New Formation
  - b. Amendment (When there is a change of Agent)
  - c. Revival (Regardless of change in Agent)
  - d. Reinstatement (Regardless of change in Agent)
  - e. Registered Agent Statement of change
  - f. Certificate of Acceptance by Registered Agent



2. **Get Previous Officer Information** is a new button added to the Initial List Filing flow. It allows External Users to pull in officer information they entered in previous steps. This feature will enhance efficiency by quickly adding the information to the filing flow.
