WHEREAS, GLOBAL MACRO ASSET MANAGEMENT LLC, CRD No. 171568, is a Nevada-based investment advisory firm located at 3753 Howard Hughes Parkway, Suite 200, Las Vegas, NV 89169;

WHEREAS, DONALD EDMUND CODY, CRD No. 1200329, (Respondent Cody), is a Nevada-based investor adviser representative for Global Macro Asset Management LLC;

WHEREAS, on August 30, 2024, the Nevada Securities Division (Division), pursuant to the Administrator's authority under NRS § 90.410, commenced an inspection of Respondents to determine their compliance with the Nevada Uniform Securities Act, the Investment Advisers Act of 1940, and the various rules and regulations promulgated thereunder;

WHEREAS, Respondents did not properly disclose fees charged to one client, resulting in an overcharge in fees;

1 3. Respondents shall submit a check made payable to the Secretary of State in the amount of
2 \$950.23 for its fee for the inspection of Respondents' records performed under NRS §
3 90.410. The \$950.23 inspection costs are to be submitted to the Division herewith upon
4 signing of this Order.

14 and pursue any violations by Respondents in connection with other activity not set forth
15 herein.


16 7. Nothing in this Order is intended to limit or create for third parties any private remedies


