17 document preparation service activity as defined in NRS 240A.030.

18 Be advised, if you fail to comply with this Cease and Desist Order, this office may
19 seek to have a civil action filed against you as set forth in NRS 240A.280 which may
20 include, without limitation, the imposition of a civil penalty in an amount up to \$5,000 for
21 each violation, restitution to any victims of your activity, and attorneys' fees.

1 EXHIBIT A

2 FACTS AND RATIONALE FOR CEASE AND DESIST ORDER

3 TO: Mr. M. Joseph Miller II (aka Mack Miller)

4 Case No. DC20170509-001

5 NRS 240A.100 requires any person engaging in the business of a document
6 preparation service to be registered with the Secretary of State.

7 The State of Nevada, Office of the Secretary of State finds that you violated NRS
8 240A.100 as follows:

- 9 1. You are not registered with the Secretary of State as a document preparation
10 service.
- 11 2. You are operating as a document preparation service through your sole proprietor
12 business, M & A LEGAL MANAGEMENT.
- 13 3. For compensation and at the direction of a client, you assist clients in legal matters
14 and hold yourself out as a person who provides such services, as follows:
- 15 a) Your website: <www.millerslegal.com> advertises a number of legal services
16 you provide, including, without limitation, "Estate Planning."
- 17 b) Your website states that you "Prepare your full legal documents, which will
18 be sent directly to you for signing & notarizing."
- 19 c) You were hired by Laura Griffin, the sister of and power of attorney for
20 Marcus Garner, to represent them as their "personal or and business
21 representative" with regard to the "Estate of Garner, Marcus."
- 22 d) Laura Griffin believed you were an attorney.
- 23 e) Laura Griffin paid you \$500 as the "Initial Project Acceptance Fee."
- 24 f) On or about March 2017, you received from Laura Griffin a check in the
25 amount of \$65,800 which she believed would be deposited into a trust
26 account for the benefit of Marcus Garner.
- 27 g) The check was a death benefit from Marcus Garner's mother.
- 28 h) Instead of depositing the check in a trust account for the benefit of Marcus

Garner, you deposited the funds in your own bank account.

i) To date, you have failed or refused to return \$52,300 to Laura Griffin or Marcus Garner.

j) Laura Griffin obtained a Court order requiring you to pay \$53,000 to her, but you have not done so.
