Any willful violation of this Order may subject you to prosecution and criminal penalties pursuant to NRS 240A.290.

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

- 1. You are not registered with the Secretary of State as a document preparation service.
- 2. You are operating as a document preparation service as Fictitious business name, VEGAS DOCUMENT AND NOTARY.
- 3. For compensation and at the direction of a client, you advertise that you will assist clients in Immigration matters, DMV, Notary and Document Preparation Services and hold yourself out as a person who provides such services, as follows:

- d) On the above listed website and social media, you note Nevada Business License NV20201753930 with Expiration date: 4/30/2021. This business license is filed under "SERGE ARMANI with dbas: USA IMMIGRANT SERVICE, IMMIGRANT DOCUMENT HELP CENTER, VEGAS INTERPRETERS and VEGAS DOCUMENT & NOTARY".
- e) On May 29, 2020, Mr. Serge Armani became an approved registered Document Preparation Service NVDP2020424154.
- f) To date you have failed to comply by registering as a Document Preparation Service pursuant to NRS240A.100.
