Be advised, if you fail to comply with this Cease and Desist Order, this office may seek to have a civil action filed against you as set forth in NRS 240A.280 which may include, without limitation, the imposition of a civil penalty in an amount up to \$5,000 for each violation, restitution to any victims of your activity, and attorneys' fees. Any willful violation of this Order may subject you to prosecution and criminal penalties pursuant to NRS 240A.290.

**TO: Mr. Arturo Gutierrez More**

**Case No. DC20210310-010**

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

1. You are not registered with the Secretary of State as a document preparation service.

2. You are operating as a document preparation service through the business entity, **AMERICA SERVICES MULTI SERVICES LLC**.

3. For compensation and at the direction of a client, you advertise that you will assist clients in Tax preparation matters and hold yourself out as a person who provides such services, as follows:

a) Your Facebook social media: <https://www.facebook.com/arturo.gutierrez.50552> advertises "AMERICA SERVICES MULTI SERVICES LLC." You share numerous pictures of Ms. Lillian More's Facebook page that advertise a Giveaway to clients of a Raffle to win an "InstaPot", by means of being a customer at said business.

b) This is the same business as Ms. Lilian More Cabriaes, Owner/Manager of "AMERICA SERVICES MULTI SERVICES LLC." located at, 3376 S. Eastern Ave. #174, Las Vegas, NV 89169.

c) On March 5, 2021, Ms. More Cabriaes submitted a "Registrant Notice" pursuant to NRS240A.160 to the Office of the Secretary of State, where she lists Arturo Gutierrez More as a Registrant and/or staff in her business, "AMERICA SERVICES MULTI SERVICES LLC."


d) To date you have failed to comply by registering as a Document Preparation Service pursuant to NRS240A.100.
