Any willful violation of this Order may subject you to prosecution and criminal penalties pursuant to NRS 240A.290.



EXHIBIT A
FACTS AND RATIONALE FOR CEASE AND DESIST ORDER

TO: NEVADA QUICK DIVORCE

Case No. DC20180220-012

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

1. You are not registered with the Secretary of State as a document preparation service.
2. For compensation and at the direction of a client, you assist clients in legal matters and hold yourself out as a person who provides such services, as follows:
 - a) Your websites: www.lasvegasannulmentexpert.com and www.nevadadivorce.us advertise several legal services you provide, including without limitation, "Divorces and Annulments".
 - b) Your websites list several reviews that name you, "Michael", as providing said services. Reviews such as: "Mike is a life saver he is the best!! Simple easy no hidden BS it was over in a matter of days. I highly recommend NV Quick Divorce.", "Terrific professional and excellent. Mike is wonderful.", "Contacted Nevada Quick Divorce and spoke to "Mike"... He told me the process in detail and ensured me that everything was going to be okay. Mike was attentive to my questions and needs."
3. Our office was notified by Mr. Timothy Ridge that you filed a fraudulent divorce on his behalf, and in doing so provided legal advice, explanation, opinion or recommendation to a client about possible legal rights, remedies,

1 defenses, options or the selection of documents or strategies. You are aware of
2 the requirement to register as a Document Preparation Service pursuant to
3 NRS240A.100.

4 4. You attempted to register with the Secretary of state as a Document
5 Preparation Service in 2014, registration number NVDP201431781
6 REJECTED: 7/10/2014.

7 5. Your wife and co-owner of Nevada Quick Divorce, Victoriya Sokol provided a
8 written statement to our office on July 7, 2014 stating, *"Please be advised that*
9 *Mr. Sunde is not required to be licensed as he has been mostly retired for the*
10 *past few years. Operating the business Nevada Quick Divorce is my*
11 *responsibility. Therefore, I have obtained a Document Preparation Services*
12 *license issued by your office."*

13 6. You are operating as a document preparation service through your sole
14 proprietor business, NEVADA QUICK DIVORCE and under your wife's
15 Document Preparation Services registration.

16 7. You hold a current Nevada Business License NV20101741836, Expiration
17 Date: 10//31/2021, under J. Michael Sunde & Viktoriya Sokol dba NEVADA
18 QUICK DIVORCE.

19 8. Pursuant to NRS240A.240 (1)(g), you are prohibited from providing legal
20 advice: A registrant shall not...(g) provide any advice, explanation, opinion or
21 recommendation to a client about possible legal rights, remedies, defenses,
22 options or the selection of documents or strategies, except that a registrant
23 may provide to a client published factual information, written or approved by
24 an attorney, relating to legal procedures, rights or obligations.
