- c) On March 24, 2021, you posted a video to the "TORO TAXES (4250 Rainbow)" Facebook page that features you as "Rigoberto Ruiz, Especialista de Taxes".
- d) The earliest video post on your "Rigo Toretto" Facebook page, was February 10, 2020, advertising the business location for, "TORO TAXES (4250 Rainbow)."
- e) To date you have failed to comply by registering as a Document Preparation Service pursuant to NRS240A.100.
