FACTS AND RATIONALE FOR CEASE AND DESIST ORDER

TO: CHRISTOPHER JOHNSON

Case No. DC20210419-006

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

- 1. You are not registered with the Secretary of State as a document preparation service.
- 2. You are operating as a document preparation service through the business entity, HOPE SAVES dba DMV Registration Services.
- 3. For compensation and at the direction of a client, you advertise that you will assist clients in DMV Registration matters and hold yourself out as a person who provides such services, as follows:
- a) On May 23, 2014, you initiated a Document Preparation Application (NVDP2014523256), for registration of a Document Preparation Service. Your application was rejected on July 28, 2014, for failure to provide Nevada Business License information and failure to complete the application process.
- b) On March 23, 2021, our office was given notice by the Nevada Department of Motor Vehicles that you are providing third party DMV services along with Ms. Daniella Mims, who is a Document Preparation Service Registrant with the Secretary of State's office. You and Daniella Mims attend DMV appointments together and step up to their service windows together.
