You are hereby directed and ordered to immediately **CEASE AND DESIST** all document preparation service activity as defined in NRS 240A.030.

Be advised, if you fail to comply with this Cease and Desist Order, this office may seek to have a civil action filed against you as set forth in NRS 240A.280 which may include, without limitation, the imposition of a civil penalty in an amount up to \$5,000 for each violation, restitution to any victims of your activity, and attorneys' fees. Any willful violation of this Order may subject you to prosecution and criminal penalties pursuant to NRS 240A.290.

FACTS AND RATIONALE FOR CEASE AND DESIST ORDER  
TO: CHRISTOPHER JOHNSON

Case No. DC20210419-006

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

1. You are not registered with the Secretary of State as a document preparation service.

2. You are operating as a document preparation service through the business entity, **HOPE SAVES dba DMV Registration Services**.

3. For compensation and at the direction of a client, you advertise that you will assist clients in DMV Registration matters and hold yourself out as a person who provides such services, as follows:

a) On May 23, 2014, you initiated a Document Preparation Application (NVDP2014523256), for registration of a Document Preparation Service. Your application was rejected on July 28, 2014, for failure to provide Nevada Business License information and failure to complete the application process.

b) On March 23, 2021, our office was given notice by the Nevada Department of Motor Vehicles that you are providing third party DMV services along with Ms. Daniella Mims, who is a Document Preparation Service Registrant with the Secretary of State's office. You and Daniella Mims attend DMV appointments together and step up to their service windows together.
