FACTS AND RATIONALE FOR CEASE AND DESIST ORDER

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

- 1. You are not registered with the Secretary of State as a document preparation service.
- You are operating as a document preparation service through the business USA
 TU CASA TAX SERVICES, INC.
- 3. For compensation and at the direction of a client, you advertise that you will assist clients in Tax preparation matters and hold yourself out as a person who provides such services, as follows:
- a) The Facebook social media: https://www.facebook.com/Usa-Tu-Casa-Tax-Services-1399432140352038 advertises "USA TU CASA TAX SERVICES INC."
- b) This is the same business as Ms. Rosario P. Hernandez, Owner/Manager of "USA TU CASA TAX SERVICES INC.", located at 4260 E. Charleston Blvd., Las Vegas, NV 89104.
- c) On May 20, 2021, representatives from the Office of the Secretary of State visited said business noted above. Pursuant to NRS 240A.265, The Secretary of State may conduct periodic, special or any other examinations of any records required to be maintained pursuant to this chapter or any other provisions of NRS pertaining to the duties of a registrant as the Secretary of State deems necessary to determine whether a violation of this chapter or any other provision of NRS pertaining to the duties of a registrant has occurred.

- d) On May 20, 2021, representatives observed said business offering tax preparation open for business and two individuals present, one of them being Hilda Vergara, who was working on several files on her desk.
- e) Hilda Vergara provided a business card from "USA TU CASA TAX SERVICES INC." to the representatives from the Secretary of State's office that noted Hilda Vergara as "Tax Specialist."
- f) Hilda Vergara was asked to produce her Document Preparation Registration certificate and was unable to provide one to the representatives from the Secretary of State.
- g) To date you have failed to comply by registering as a Document Preparation Service pursuant to NRS240A.100.
