Be advised, if you fail to comply with this Cease and Desist Order, this office may seek to have a civil action filed against you as set forth in NRS 240A.280 which may include, without limitation, the imposition of a civil penalty in an amount up to \$5,000 for each violation, restitution to any victims of your activity, and attorneys' fees. Any willful violation of this Order may subject you to prosecution and criminal penalties pursuant to NRS 240A.290.

**EXHIBIT A**  
**FACTS AND RATIONALE FOR CEASE AND DESIST ORDER**  
**TO: ALEJANDRO REY ALEJANDREZ ALEXANDER**

**Case No. DC20190312-003**

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

1. You are not registered with the Secretary of State as a document preparation service.

2. You are operating as a document preparation service through the business entity, **EAGLE TAX SERVICE LLC**, which is registered under your wife Norma Alejandrez.

3. For compensation and at the direction of a client, you advertise that you will assist clients in Tax Preparation and Immigration matters and hold yourself out as a person who provides such services.

4. You previously held a Document Preparation Services registration **NVDP2014914391** but let it expire on **December 15, 2019**.

5. You re-applied for your Document Preparation Services registration **NVDP2014914391** on December 23, 2019 and failed to complete the application. The re-application was rejected for failure to complete within 120 days.

6. You held and operated under your sole proprietor Nevada Business License **NV20141762405** that expired December 31, 2020.

7. You continue to operate under your wife Norma Alejandrez' Nevada business License **NV20211995687** for business entity **EAGLE TAX SERVICE LLC**.

8. You are aware of the requirements of NRS240A and to date you have failed to comply by registering as a Document Preparation Service pursuant to NRS240A.100 and meet all the requirements.


