
15 **PLEASE TAKE NOTICE** that the State of Nevada, Office of the Secretary of State

22 include, without limitation, the imposition of a civil penalty in an amount up to \$5,000  
23 for each violation, restitution to any victims of your activity, and attorneys' fees. Any  
24 willful violation of this Order may subject you to prosecution and criminal penalties  
25 pursuant to NRS 240A.290.

**FACTS AND RATIONALE FOR CEASE AND DESIST ORDER**

**TO: NORMA A ALEJANDREZ**

**Case No. DC20190319-014**

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

1. You are not registered with the Secretary of State as a document preparation service.

2. You are operating as a document preparation service through the business entity, **EAGLE TAX SERVICE LLC**.

3. For compensation and at the direction of a client, you advertise that you will assist clients in Tax Preparation and Immigration matters and hold yourself out as a person who provides such services.

4. You previously held a Document Preparation Services registration NVDP2014914391 but let it expire on **May 13, 2021**.

5. You hold and operate under Nevada Business License **NV20211995687** for business entity **EAGLE TAX SERVICE LLC**.

6. Your Nevada business License NV20211995687 for business entity **EAGLE TAX SERVICE LLC** is active, expires **January 31, 2022**.


