Be advised, if you fail to comply with this Cease and Desist Order, this office may seek to have a civil action filed against you as set forth in NRS 240A.280 which may include, without limitation, the imposition of a civil penalty in an amount up to \$5,000 for each violation, restitution to any victims of your activity, and attorneys' fees. Any willful violation of this Order may subject you to prosecution and criminal penalties pursuant to NRS 240A.290.

4 Case No. DC20201123-002

5 NRS 240A.100 requires any person engaging in the business of a document
6 preparation service to be registered with the Secretary of State.

7 The State of Nevada, Office of the Secretary of State finds that you violated NRS
8 240A.100 as follows:

9 1. You are not registered with the Secretary of State as a document preparation
10 service.

11 2. You are operating as a document preparation service through your sole
12 proprietor business, **Marcos Ojeda Valadez dba Nevada DMV Services Experts**
13 **Co.**

14 3. For compensation and at the direction of a client, you advertise that you will
15 assist clients in DMV matters and hold yourself out as a person who provides such
16 services, as follows:

17 a) Your Facebook social media: <https://www.facebook.com/marcos.valadez.923>
18 advertises a number of document preparation services you provide, including, without
19 limitation, "Registrations, Titles, Title Recovery, Title Correction, Permits and
20 Renewals."

21 4. You previously applied for a Document Preparation Services Registration
22 (NVDP202011244479) on 11/24/2020. However, you never completed the process, and
23 the application was **rejected on 3/25/2021**.

24 5. You hold a sole proprietor Nevada Business License (NV20201904207) with
25 expiration date **9/30/2021**, under "Marcos Ojeda Valadez dba Nevada DMV Services
26 Experts Co".
