
You are hereby directed and ordered to immediately **CEASE AND DESIST** all document preparation service activity as defined in NRS 240A.030.

Any willful violation of this Order may subject you to prosecution and criminal penalties pursuant to NRS 240A.290.

**FACTS AND RATIONALE FOR CEASE AND DESIST ORDER**  
**TO: LUIS A. BEJARANO TARABILLO**

**Case No. DC20190617-005**

NRS 240A.100 requires any person engaging in the business of a document preparation service to be registered with the Secretary of State.

The State of Nevada, Office of the Secretary of State finds that you violated NRS 240A.100 as follows:

1. You are not registered with the Secretary of State as a document preparation service.

2. On December 21, 2017, you initiated the application for Document Preparation Service Registration NVDP201712212200. On May 17, 2018 the application was **REJECTED** for failure to complete within 120 days; no Surety Bond submitted.

3. You are operating as a document preparation service through the entity, **TAX CENTRAL EXPRESS**.

4. You have been known to operate under business names: **LAS AMERICAS, INC. dba TAX CENTRAL EXPRESS**.

5. Currently you are operating under business name: **TAX CENTRAL EXPRESS** at business location **3376 S. Eastern Ave., Suite #115 Las Vegas, NV 89104**.

6. For compensation and at the direction of a client, you advertise on your Facebook page <https://www.facebook.com/profile.php?id=100057534104385> that you will assist clients in Tax Preparation matters.

7. For compensation and at the direction of a client, you advertise on your website <https://www.taxcentralexpress.com> that you will assist clients in Tax Preparation matters, DMV Services and as a Notary Public.

To date you are not in compliance with registering as a Document Preparation Service pursuant to NRS240A.100.
